## Membership Classifications

We thank you for your interest in membership with our club. Please select the from the membership options below the one that best suits your needs.

### **FULL MEMBERSHIP**

Initiation Fee \$3,500.00 | Dues \$250.00 per month

Our full membership is inclusive of all immediate family members up to the age of 23 (25 if still in college). Full use of facility includes clubhouse facility, golf course, swimming pool, and tennis courts.

### **CORPORATE MEMBERSHIP**

Initiation Fee \$5,000.00 | Dues \$215.00 per month per designated employee

Corporation pays one initiation fee for membership. Minimum number of three (3) employees to qualify for corporate membership. Full use of facility.

### **JUNIOR MEMBERSHIP**

Initiation Fee \$2,000.00 | Dues \$195.00 per month

Available to individuals or couples 30 years of age or under. Full use of facility.

### **SENIOR MEMBERSHIP**

Initiation Fee \$2,000.00 | Dues \$195.00 per month

Must be 65 years of age or older. Full use of facility on Monday through Friday. Use of club on weekends at reduced greens fee and cart fee.

### **SOCIAL MEMBERSHIP**

Initiation Fee \$1,000.00 | Dues \$75.00 per month

Member is provided two (2) reduced rate rounds of golf per quarter (8 rounds per year). Member is allowed unlimited use of tennis courts, pool, and clubhouse facility.

### **NON-RESIDENT MEMBERSHIP**

Initiation Fee \$1,500.00 | Dues: \$140.00 per month

Individuals or couples who live at least 20 miles away from facility (as determined by Google search of primary address). Full use of facility.

### **PERSONAL CART/TRACKAGE**

Fee \$75 per month

Property owners or those that live within a 2-mile radius of the club, may use their own golf cart (requires a 12-month commitment).
